

## **Lightning Demo - Terms of Use**

Make your first lightning payment with Zebpay

### **Demo Product Features/Demonstration Service (the "Demo"):**

A Demo for trial users (the "User") to test the integration of Lightning Network protocol on Zebpay - which will allow anyone to make an actual lightning transaction, funded by Zebpay to avail pre-defined services on select Lightning stores, subject to trial users agreeing to the Terms of Use as laid out.

### **How does it work?**

#### **Step 1:**

Users need to verify their phone no. and register with Zebpay.

#### **Step 2:**

User will select from a closed list of stores/ Lightning Network addresses - with which Zebpay has officially opened a Lightning Network channel - to make the payment.

#### **Step 3:**

They will be able to do a live Bitcoin transaction (live transactions with real bitcoins are on what is called 'mainnet') whereby lightning is used to transact on stores that allow users to play a game, give a tip to a researcher or buy a virtual good / service (eg: ebook), etc, subject to stores available with Zebpay.

#### **Step 4:**

The amount will not be paid by the User, but will be paid by Zebpay to demo the technology.

#### **Step 5**

If User(s) does not wish to register with Zebpay, they can do a test transaction on the dummy network (called "testnet") with no real satoshis / bitcoins being spent.

### **Demo Terms of Use**
